1/24/18 Visitors Comments Mrs. Deana Smith addressed the board with concerns over a bus stop that used to be part of the route. This year with the change in routes it no longer goes all the way to the drive where her children would have normally gotten on the bus. There are other children that get on at that stop. This would involve approximately 6 students. Her child is in preschool and is very young to have to walk this distance. Currently a family member has to take the children up the road to catch the bus. Part of her concern is that if that person was not there when the bus delivered the children they would have to walk along the highway to get to their driveway. The distance is approximately 200 feet.

Mrs. Burrow addressed this concern reassuring Mrs. Smith that the bus drivers are trained to never leave a child off the bus without someone being there. If s the parents cannot be reached the children will be returned to school.

Mrs. Smith asked the Administration and Board to re-evaluate this route before the start of school next year.
