Shall the Board of Education of the Cole County R-V School District, Missouri, be authorized to eliminate fully the Proposition C Sales Tax Rollback in its operating levy under Section 164.013 R.S. Mo. in order to provide additional funds to meet the operating needs of the District?

(If approved, this proposition would fully eliminate the Proposition C Sales Tax Rollback and is estimated to increase the school district's adjusted operating levy from \$3.0337, currently, to \$3.3852 per one hundred dollars of assessed valuation for the 2020 Tax Year and can be applied to the assessed valuation for each year thereafter.)

Mrs. Burrow explained a little history to the Sales Tax Prop C waiver as it has been explained to her by Bruce Johnson from L.J. Hart office.


In 1982 there was a law passed that Sales Tax funds would go to schools and roads. At that time schools could opt to take partial funds rather than receive the entire amount. In 1993 the schools state funding was reduced because the foundation formula was no longer fully funded. At that time most schools requested that the wavier be removed granting schools the full funding.


At this time our district could use the full funding to help the district with increasing salaries and facility needs.

What that means to the district patrons is the operating levy would be increased by .351 per assessed valuation. The waiver removal does not change the assessed valuation for a tax payer, it just puts more of the money assessed into the school taxes.

Mrs. Burrow also explained that the district can only provide information for this proposal.
