3/15/17	Mrs. Burrow explained to the Board that her recommendation would be to leave the SECE Insurance Group as she feels it would not be a financially solvent decision for our district to remain with them. She also explained that there may be a buyout clause that SECE would try to obtain from us. The company by-laws do not explain what if anything that may be, there seems to be some conflicting information concerning the buyout clause. Mrs. Burrow does recommend joining the OSBA Insurance consortium and the district funding the HSA Plan 5 at \$4896.00 per employee annually.

Mrs. Burrow informed the Board that she had contacted DESE to see if there is away to get around this mandate, but there is not. This has to do with local lunch prices matching the federal lunch reimbursement prices. It has been several years since breakfast prices have been increased. Mrs. Burrow recommended increasing the breakfast and lunch prices by \$.10 for all grades K-12.
